#### 44th USS Thresher Memorial Service

The 44th anniversary memorial service of the loss of the USS Thresher was held on April 14, 2007. This year's service was held in Kittery at the R.W. Traip Academy. The welcoming address was given by Captain Iverson, Commander, Portsmouth Naval Shipyard. His welcoming statement was followed by remarks by Captain Gregory R. Thomas, PNS Operations Officer and Prospec-

tive Commanding Officer, Pearl Harbor Naval Shipyard and Commander Rovert E. Cosgriff, CO, USS Hyman G. Rickover. It was then a pleasure to

listen to Lori Arsenault, daughter of ENCA(SS) Tilmon Arsenault, perform the Navy Hymn. This set the stage for the somber Toll-

ing of the Bells for the 129 men who lost their lives on April 9, 1963. While Kevin Galeaz and Bill Tebo read the names and STSCM(SS) Jeff Rowe tolled the bell, the melodic sounds of a bagpipe, played by Patrick Boyle, could be heard in the distance. A poinant powerpoint slideshow of photos of the lost ran in unison with the reading of the names.

After Chaplin Steven Bartell's Benediction, the service continued down



at the waterfront. ChaplinBartell led us in a prayer which was followed by

a gun salute from the Portsmouth Naval Shipyard Rifle Team. While the wreath was being prepared, Mr. George Stevens, United States Submarine Veteran, played taps. Mrs. John Harvey, the wife of LT

opportunity to
release the wreath
off the dock into
the outgoing
tide. Piper Boyle
concluded the
ceremony with
the Navy Hymn.

# To Perpetuate the Memory



Robert Donald Biederman was born on August 27, 1930, in Hartford,

Connecticut. While attending Weaver High School in Hartford, he was active in sports, including track, cross country, and basketball. After being graduated from high school in 1948, he entered the University of connecticut, and in June 1950, he was accepted as a midshipman at the U.S. Naval Academy at Annapolis. He was

graduated from the Academy with the class of June 1954, and commissioned as an ensign.

His first assignment as a naval officer was aboard the Newport-based destroyer U.S.S. Hyman (DD 732). After 3 years of sea duty, Robert was

selected for postgraduate study at Webb Institute of Naval Architecture, Glen Cove, Long Island, N.Y. He successfully completed the course of study and was graduated with a master of science degree in naval architecture.

Robert volunteered for submarine duty and entered the Submarine School at the U.S. Naval Submarine Bass, New London, Connecticut. His

first assignment in submarines, after completing the course of instruction, was in the U.S.S. Cavalla (SS 244). It was while serving in that command that Robert qualified as a submariner and was awarded his gold dolphins; insignia of the submariner.

He reported to the Portsmouth Naval Shipyard in June 1962, where he studied in the Nuclear Power Submarine Familiarization Training Unit until December. In January 1963, Robert was assigned to the U.S.S. Thresher (SSN 593), in his capacity as senior ships superintendent for non-nuclear work for the Portsmouth Naval Shipyard.

During his naval career, Robert had been awarded the Navy Occupation Service Medal with European Clasp and the National Defense Service Medal.

He is survived by his widow, the former Bettie Boehringer of Meridan, Connecticut; sons, Gregory, Bruce and Eric; and a daughter, Deborah. He also leaves his mother, Mrs. Dorothy S. Biederman; four brothers, and three sisters, all of Hartford, Connecticut.

Roy Overton Denny, Jr., was born on February 8, 1939, in New York City. He attended schools there until his family moved to Groton, Conn., in November 1950. He was graduated from Robert E. Fitch High School, Groton, in June 1957.

Roy's career in the Navy and in submarines was apparent from an early age. His father, who died in 1956, served in submarines during a 28-year career in the Navy. Roy's interests were directly connected with ships and the sea; nautical books and ship models were his favorite hobbies.

After basic training at the Navy's Submarine School at the U.S. Naval Submarine Base, New London, Conn., Roy enlisted in the regular Navy in October 1957.

His first submarine duty was in the U.S.S. Threadfin (SS 410), in which he became qualified as a submariner,

and was awarded his silver dolphins. In November 1958, he attended the Navy's Electrician's Mate School and following graduation he was selected for advanced training in nuclear power. Roy successfully completed the course of training at New London, and at the special prototype training

unit at Windsor Locks, Conn. He was assigned to the U.S.S. Thresher (SSN 593) on February 27, 1961.

He is survived by his widow, Mrs. Carol Denny, and a daughter, Teresa Anne. He also leaves his mother, Mrs. R. O. Denny, Sr.; a brother, Myles, and two sisters, Catherine and Elizabeth, all of Groton, Conn.
