July 2007 Lobsterbake Minutes

The Treasurer's Report was read by Dennis O'Keeffe. The current balance is \$5765.58.

- Gary Hildreth delivered a check to the R.W. Traipp Academy. The money will be used for their Project Graduation which is an alcohol free event for graduates. They were very appreciative of the gift.
- District 1 Meeting was attended by Larry Oiler and Gary Hildreth. The



big issue of discussion is the expiration of the USSVI insurance policy. This means that there is no more nationwide coverage and each base is being asked to purchase individual policies at about \$500. This lack of group coverage may cause problems

for the Thresher Memorial Service and may force the service back on the shipyard.

Lori Arsenault & the USS Thresher Featured on PBS History Detectives

On September 10, PBS' History Detectives ended its fifth season by featuring a story about the USS Thresher. The show featured an interview with Lori Arsenault, daughter of ENCA(SS) Tilmon Arsenault along with the Thresher Base website. The show focused on authenticating engineering notes for a submarine that referred to the Portsmouth Naval Shipyard, as well as to the USS Thresher (SSN 593). These papers were in the possession of the great grand nephew of Leonard E. Morgan and he wanted to know what the papers represent, if his uncle worked on the USS Thresher and he would like to know more about the history of the Thresher.

In late May, Thresher Base Secretary

Kevin Galeaz was contacted by Kyle Silveri from Lion TV regarding the PBS documentary series History Detectives. Kevin explained the USSVI Creed and Thresher Base's practice of the Creed by holding an annual memorial service for the family members of those lost aboard the USS Thresher. Kevin also offered to put her in contact with Lori Arsenault.

Kevin described how the loss of Thresher led to the creation of the SUBSAFE Program. Kevin provided a description of the SUBSAFE Program along with additional references, including one that links USS Thresher with the Space Shuttle Columbia.

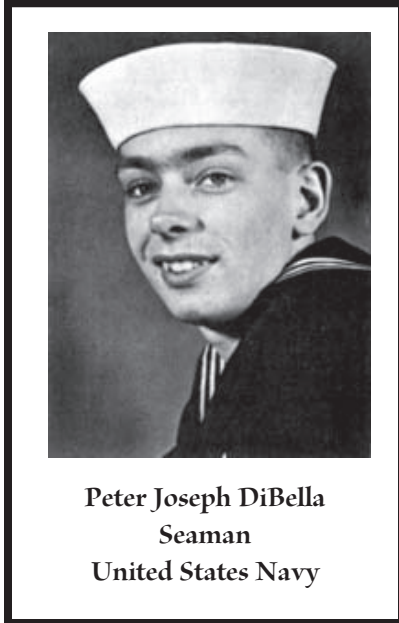
To Perpetuate the Memory



Peter Joseph DiBella was born on July 14 1943, in Portsmouth, N.H., the son of Mr. and Mrs. John J. DiBella.

During his youth in Portsmouth, Peter's interests were always with the sea, and his ambition was to be a man of the sea.

When he was graduated from high school, his school's yearbook featured a photograph of the submarine U.S.S. Thresher (SSN 593).

On January 16, 1962, Peter enlisted in the Navy, and received his basic

training at the U.S. Naval Training Center, Great Lakes, Ill. Upon completing his training, he was enrolled in the Navy's Electronic Technicians School at the great Lakes.

Peter volunteered for submarine duty, and being accepted, he was enrolled as a student in the Submarine School at the U.S. Naval Submarine Base, New London, Conn. Following graduation,

he was assigned as a crew member of the nuclear-powered submarine U.S.S. Thresher (SSN 593). He reported for duty at the Portsmouth Naval Shipyard on January 5, 1963.

Peter had been awarded a letter of commendation from the commander of Submarine Development Group 2, for his outstanding performance of duty.

Peter is survived by his parents, Mr. and Mrs John J. DiBella, a brother, Frank and a sister, Elizabeth Ann, all of Portsmouth, N.H. He also leaves his aunts, Miss Antonette DiBella of Hartford, Conn., and Mrs. Mildred Saffell of Portsmouth.

Don Roy Dundas was born on July 21 1940, in Dodge City, Kans. During his early school years, he became interested in electronics, and was a licensed "ham" operator at age 14. He was a member of the American Relay League. While attending high school, Don was the chief electrician for the school's dramatic department where he was responsible for lighting and sound effects. He also worked for a local radio station prior to enlisting in the Navy on August 29, 1958.

He received his basic training at the U.S. Naval Training Center, Great Lakes, Ill., and later attended the Navy's Electronics Technician School, and the Sonar Plotting School at the U.S. Naval Submarine Base, New London, Conn. Don volunteered for

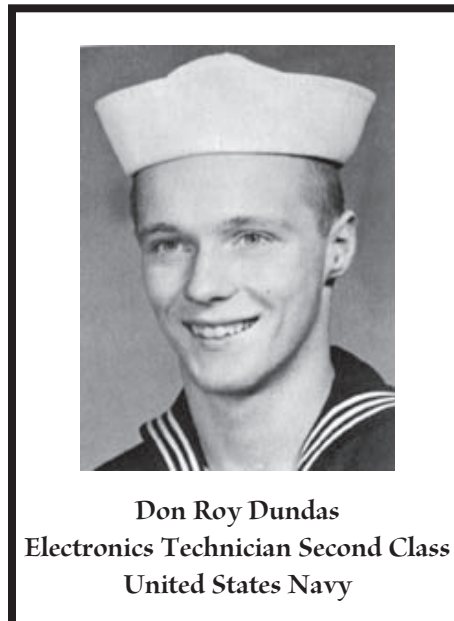
submarine duty and upon being accepted, he was enrolled as a student in the Navy's Submarine School at the submarine base.

On March 18, 1960, he was graduated from the school and assigned to his first submarine, the U.S.S. Balao (SS 285). While serving in the Balao, he became qualified as a submariner and was awarded his silver dolphins. Don had also earned the Navy's Good Conduct

Medal.

On November 17, 1961, Don received his orders to the nuclear-powered submarine U.S.S. Thresher (SSN 593).

He is survived by his widowed mother, Mrs. Gladys Carol Dundas of Russell, Kans., and a grandmother, Mrs. Clarence Blakeway of Colby, Kans.
