- Albacore Park - repaving has taken place, attendance has been steady this




summer and members of the USS Greenville have been painting the ship.

Submarine New Hampshire Completes First Voyage

New Hampshire (SSN-778), the nations newest and most advanced nuclear-powered attack submarine, returned to the Electric Boat shipyard today following the successful completion of its first voyage in open seas, called alpha sea trials.

New Hampshires alpha sea trials included submerging for the first time, performing a range of submarine and propulsion-plant operations and conducting high-speed runs on the surface and underwater to demonstrate that the ships propulsion plant is fully mission-capable. New Hampshire will be delivered to the U.S. Navy by the end of summer.

"I'm privileged to have participated in the successful propulsion plant sea trial for a Virginia-class submarine, said Director of Naval Nuclear Propulsion Adm. Kirkland Donald, who directed the sea trials. New Hampshire, the fifth of the Virginia Class, performed satisfactorily in all operations and this success is a direct result of the hard work of both the crew and the shipbuilders. The Navy and the nation need submarines like New Hampshire and I am confident that she will support the missions for which she was designed."

Watching the crew and shipbuilders working as one to put this submarine through its paces was inspirational,

said Electric Boat President John P. Casey. It was a superb effort by everyone involved, and reflects the extraordinary commitment of the Navy/industry team to sustain the success of the Virginia-class Submarine Program.

Its significant to note that this team reduced the time span between christening and sea trials from 11 months on the first ship of the class to less than six weeks on New Hampshire, Cased added. Thats a remarkable achievement, and I deeply appreciate the contributions made by the Navy personnel, shipbuilders and suppliers who made it happen.

Also participating in the sea trials were Vice Adm. Paul Sullivan, commander, Naval Sea Systems Command; Rear Adm. Bruce Grooms, commander, Submarine Group Two; Rear Adm. William Hilarides, program executive officer Submarines; Capt. Christopher Pietras, supervisor of shipbuilding in Groton; Michael W. Toner, executive vice president Marine Systems, General Dynamics; John Holmänder, Electric Boat vice president and Virginia-class program manager; and Becky Stewart, Northrop Grumman Newport News vice president submarine program. New Hampshire is commanded by Cmdr. Michael Stevens.

Saluting During the National Anthem

The Fleet Reserve Association (FRA) reports that Senator James Inhofe (R-Okla.) will introduce legislation that gives veterans and active-duty personnel not in uniform the option of saluting the flag during the playing of the National Anthem. Senator Inhofe sponsored legislation last year (S. 1877) that permits veterans and servicemembers out of uniform to render a salute during hoisting, lowering, or passing of the flag. The provisions were eventually included in the FY 2008 Defense Authorization Act (enacted Jan. 28, 2008), but the legislation did not authorize a salute during the Star-Spangled Banner.



To Perpetuate the Memory



James Leonard Snider was born on July 22, 1939, in Clayton, N. Mex., son of Mr. and Mrs. Clinton Snider. He spent his early boyhood on his parent's ranch where he became proficient in the operation of farm machinery. He worked as a heavy-duty equipment operator for 2 years prior to entering the naval service.

He attended Pajarito Elementary School in Albuquerque, and Belen


High School in Belen. His hobbies were hunting and fishing in the mountains of New Mexico.

Enlisting in the Navy on February 10, 1958, he received his basic training at the U.S. Naval Training Center, Great Lakes, Ill., and upon completion, was selected to attend the Navy's Machinist's Mate School.

Following his graduation from that school, he was assigned to the destroyer tender U.S.S. Bryce Canyon (AD 36), until he was

selected for advance training in nuclear power. James was one of the first to enter nuclear power training specifically for duty in surface ships. However, he volunteered for submarine duty, and upon being accepted, he was ordered to the Submarine School located at the U.S. Naval Submarine Base, New London, Conn. Successfully completing the course of instruction, he was assigned to the nuclear-powered submarine U.S.S. Thresher (SSN 593) on March 19, 1963.

In addition to his parents, James is survived by his widow, Mrs. Phyllis A. Snider; two daughters, Michelle Marie and Sherry Ann; five brothers, Bud, Andrew, Ernest, John and Jerry; three sisters Mrs. Allen, Mrs. James Templeton, and Miss Christine Snider.

Larry Wayne Freeman was born on September 27, 1939, in Des Moines, Iowa. He was graduated from Runnells Consolidated High School, Runnells, Iowa, in June 1959, near the top of his class.


He served as senior class president and was selected to the Iowa all-State high school football team. Larry was also active in other school activities, including the school newspaper, the choral group, and participated in several of the school plays.

He enlisted in the Navy on July 6, 1959, and received his basic training at the U.S. Naval Training Center, San Diego, Calif. Larry volunteered for submarine duty and was enrolled in the Submarine School at the U.S. Naval

Submarine Base, New London, Conn. Successfully completing the course of instruction at the school, Larry was assigned to his first submarine, the U.S.S. Corporal (SS 346). While serving in the Corporal, Larry became qualified as a submariner, and was awarded his silver dolphins, on April 26, 1961.

On April 29, 1961, he received orders to the nuclear-powered

submarine U.S.S. Thresher (SSN 593).
